The association shall have power to make and adopt by a majority of all the members there of, at any meeting of the corporate members of the association all such By Laws, as may be deemed needful and proper for arguing out the objects of the association not inconsistent with the Constitution and Laws of the United States, of the state of Pennsylvania, and with the provisions of this Charter; and such By Laws may be altered, amended or added there to at any subsequent stated meeting of the association, provided no such alteration, amendment or addition shall be made at the meeting at which is it proposed, but such proposed alteration, amendment or addition, shall be entered upon the minutes and the consideration there of shall lie over until the next stated or to some other meeting, that shall be appointed for that purpose not less than ten days intervening.


