The Adult Probation Office shall provide to all persons under Court supervision at the time said individual is placed under Court supervision a copy of the Americans with Disabilities Act Policy, the Request for Reasonable Accommodations Form, the Grievance Procedure, the Grievance Form, the Addendum ADA Policy, and the guide produced by the National Association of Drug Professionals, entitled Understanding Medication to Treat Opioid Use Disorder.
- 5. Any complaints that may be filed in the Twenty-fifth Judicial District regarding alleged restrictions on the use of medicine assisted treatment shall be filed
