STAFF REPORTS:

- Matthew Croak presented the Planning Director/Engineer report and the Community Planner/Zoning Officer report.
 - The County was not approved for the Transportation Set Aside Grant for SR 150 and is working on an RFP for engineering services.
 - Discussed updates on Bald Eagle Valley Trail Phases 3, 5, & 6
 - Broadband Initiative updates, ER, and Chestnut Grove updates
 - o 911 Towers, 10M contract approval, June/July will be staging system
- The Commission reviewed the Grants Administrator Report and Grants Coordinator Report.

NEW BUSINESS:

- Winner Solar Farm Presentation, Jeff Hammond and Rob Gee, Apex Clean Energy
 - Apex is building a solar farm in East and West Keating Townships. It will produce energy for 23K homes. A discussion was held on the length of service, batteries, environmental concerns, and benefits. The project started in 2021 and is ready for land development plans to be submitted soon. RFP is in process for an engineer and next year will be focused on the permitting process. Construction is scheduled to begin in 2027 and should last about 12-18 months
- •Land Development Plans
 - Major Land Development: Allgyer Poultry Barn, Porter Township was reviewed. There were no major concerns with this plan and no comments were received.

OLD BUSINESS:

- Clinton County Comprehensive Plan- Map Grant awarded for \$70,000 of the total \$140,000 cost. DCNR Greenways grant application has been submitted for the remainder.
- Mt McKinley Tank Farm Project, Dunnstable Township: revised plans have been resubmitted, NPDES permit pending
- Wawa Gas Station is in discussion with PADOT regarding rights-of-way and traffic patterns, no updates at this time
- Leidy Township plans are still in progress
