




INSTRUCTIONS		GREENE TOWNSHIP

1. USE A BLACK PEN
2. TO VOTE YOU MUST BLACKEN THE OVAL (●) TO THE LEFT OF YOUR CHOICE COMPLETELY.
3. TO CAST A WRITE-IN VOTE FOR A PERSON WHOSE NAME IS NOT ON THE BALLOT BLACKEN THE OVAL (●) TO THE LEFT OF THE SPACE PROVIDED AND WRITE OR PRINT THE NAME IN THE BLANK SPACE PROVIDED FOR THAT PURPOSE.
4. IF YOU MAKE A MISTAKE, DO NOT ERASE. ASK FOR A NEW BALLOT.

IF YOU ARE UNABLE TO RETURN YOUR VOTED ABSENTEE OR MAIL-IN BALLOT BY THE DEADLINE, YOU MAY ONLY VOTE A PROVISIONAL BALLOT AT YOUR POLLING PLACE ON ELECTION DAY, UNLESS YOU SURRENDER YOUR ABSENTEE OR MAIL-IN BALLOT AND ENVELOPE TO THE JUDGE OF ELECTIONS TO BE VOIDED TO VOTE BY REGULAR BALLOT.
